# ***MEMBERSHIP GUIDELINES***

## **Membership Eligibility**

Individual memberships are available for members ages 15 and older. Anyone 14 and under must be included on a family membership with an adult.

All family memberships apply to individuals residing at the same address, with children covered up to and including age 18. Proof of age and residency may be required.

## **College Students (Aged 18–23)**

College students may be included on Family Membership Options 3–5. Proof of current enrollment, such as a valid student ID, is required at the time of registration.

## **Additional Children**

Additional children may be added to Option 4 memberships only for \$50 per child, provided they reside at the same address. Proof of residency is required.

## **Substitutions - Grandparents/Caretakers**

A caretaker or grandparent may be substituted for a spouse.

Substituted individuals may not be listed as children.

If an additional adult is added beyond the standard membership structure, a \$200 fee will apply.

## **Children & Supervision**

Children ages 4–14 may not hold a membership on their own and must be included with a supervising adult. A supervising adult is defined as a parent or legal guardian over the age of 18 living at the same address.

Children 4 years old and under are admitted free of charge.

Children ages 4–14 are not permitted to bring guests.

For the safety of all members, no child under the age of 15 may enter or remain on club property without a supervising adult over the age of 18.

# ***USING THE CLUB***

## **Membership Passes + Entry**

Membership passes are required for entry to the club. Photos must be on file for all members listed on an account before passes can be issued.

Passes will be released once all required photos have been taken and processed.

Lost passes may be replaced with valid photo identification. A replacement fee of \$10 per pass applies.

## **Lockers**

Seasonal Locker Fee: \$50

Lockers are available to rent for the full season and are not offered on a daily basis.

All lockers must be completely emptied by closing day.

Items left behind may be removed, and a \$10 cleaning fee may be applied the following season.

Each locker measures approximately 2 feet wide by 4 feet high by 4 feet deep.

Members must provide their own lock.

The club is not responsible for lost or damaged items that are not secured within a locker.

## **Showers + Dressing Rooms**

All showers must be completed by 6:30 PM to allow time for cleaning and maintenance.

Children should not play in locker rooms, showers, or dressing areas.

Members are asked to help keep these shared spaces clean and respectful.

## **Club Facilities + Courtesy**

Lake Hiawatha Swim Club follows a BYOC approach - bring your own chair and umbrella.

The club does not rent towels, chairs, or umbrellas.

A limited number of plastic chairs may be available on a first-come basis.

Chairs should be placed on grassy areas only.

Food and beverages should remain outside of the pool and pool deck.

Additional facility guidelines are outlined in the Rules and Regulations section.

# ***GUESTS + PARTIES***

## **Guests**

Guests are welcome when accompanied by a member. Guest fees are non-refundable and are not eligible for rainchecks. Members must be present when their guest arrives and remain on the property for the duration of their visit.

Members are responsible for their guests and for ensuring all club rules are followed.

Guests ages four and under are admitted free of charge. Party rate guidelines may apply when bringing more than 5 guests.

## **Guest Limits + Responsibility**

Members ages 18 and older may bring up to four guests per day.

Members under the age of 18 may bring one guest per day.

Members are financially responsible for any damage caused by their guests.

Guests may not remain on the property after the sponsoring member has left.

## **Parties**

Parties may be booked by active members of the Lake Hiawatha Swim Club only. A completed party contract is required in order to reserve a date, can be found at the gatehouse. Parties are subject to a \$100 rental fee and a \$50 maintenance fee. Guest pricing is \$18 per adult (ages 15 and older) and \$13 per child (ages 14 and under).

Guests attending a party do not need to be members of the club. A complete guest list must be submitted at least one week prior to the scheduled party date.

# ***OPERATIONS + PROGRAMS***

## **Daily Operations**

Daily operations may vary based on attendance levels, staffing, and weather conditions.

Management reserves the right to delay opening, close early, or remain closed when safety concerns arise.

Our pool amenities, diving boards and slide, open one hour after the grounds open and close one hour before closing.

Member and staff safety is always the top priority when operational decisions are made.

## **Weather + Safety Decisions**

In the event of rain, thunderstorms, lightning, or other severe weather, the pool and surrounding areas may close as a precaution.

During lightning or thunder, all members must exit the pool and pool deck and may not re-enter until conditions are deemed safe.

Access to the property may occasionally be impacted by external factors beyond the club's control, including storm gates in the surrounding area.

Weather-related closures are made with caution and care, even when conditions change quickly.

## **Communication + Updates**

All schedule changes, closures, and operational updates will be shared through official club channels.

Members can find the most up-to-date information via the club website, Facebook and Instagram, email and text alerts, and the pool voicemail.

Members are encouraged to check these channels regularly, especially during periods of unpredictable weather.

## **Swim Lessons**

Swim lessons are offered exclusively to members of the club.

Both group lessons and one-on-one sessions are available throughout the season.

Lessons are scheduled by appointment and based on instructor availability. Program details, schedules, and registration information will be shared as the season approaches and throughout the summer.

# ***FOR EVERYONE'S SAFETY***

## **WATER SAFETY ESSENTIALS**

- Diapers of any kind, including swim diapers, are not permitted in the main pool. Children must be fully potty trained to use the main pool.
- If an accident occurs in the main pool, the pool must be closed for cleaning, which impacts all members. A reclamation fee may be charged in these situations.
- Running, rough play, or unsafe behavior on pool decks or in the water is not permitted.
- Diving is only allowed from designated diving boards and in approved areas.

## **ALCOHOL + SUBSTANCE POLICY**

- Alcohol and recreational drugs are not permitted anywhere on club grounds or in the parking areas.
- Members or guests found in violation of this policy may be asked to leave and may face loss of membership privileges.

## **FLOATS, RAFTS + EQUIPMENT**

- Acceptable rafts are permitted ONLY on raft days, Sundays + Wednesdays
- Oversized rafts, boats, and large inflatables are not permitted, even on designated raft days.
- Swim aids may be used only when allowed and in designated areas.
- Restrictions may vary based on attendance and safety conditions.

**2026 Rules and Regulations**  
**General**

By entering the Lake Hiawatha Swim Club (The Club) as a Member or Guest you agree to these Rules and Regulations.

LHSC is a private owned, members only club.

The Board of Directors has the right to change, modify, suspend, add to, or withdraw any or all of these rules and regulations without notice; and reserves the right to refuse, suspend, or cancel any membership which, in its opinion, is prejudicial to the best interests of the club and its members. Anyone violating these rules and regulations hereafter promulgated may be subject to the cancellation of membership without refunding of membership, locker, or guest fees and may be expelled from the facility.

**Section 1: Membership**

1:1. Membership must be renewed annually. Memberships and lockers are sold on a seasonal basis only. No daily admissions are sold to the public. Refunds are not given for Membership or Locker fees under any circumstances.

1:2. Each member older than the age of 4 must scan a pass in order to enter the premises, the photo must match the pass given.

1:3. Membership passes cannot be sold, transferred, assigned, or used by non-members.

1:4. Members' guests must pay a daily guest fee. No rainchecks for guest fees or refunds will be given for inclement weather.

1:5. Any person who has had club privileges or membership privileges suspended or revoked shall not be admitted as a guest.

1:6. Members must be present when their guests enter the premises. No Guests may stay after a Member has left the grounds.

**Section 2: Operations**

2:1. The Club reserves the right to modify Club hours or programs without advance notification.

2:2. The Club reserves the right to make repairs, replacements, additions, or perform construction during the season.

2:3. Members must remove all property from lockers by the end of the last day of the season or it will be considered abandoned and may be disposed of by the Club.

2:4. The Club will not be held responsible for personal injuries, or the loss of or damage to personal property or automobiles of members or guests.

2:5. The Club reserves the right to regulate the Club parking areas. All persons must comply with handicap parking laws and with posted parking and driving regulations.

2:6. Radios and personal speakers are permitted if their operation does not disturb other Club members. The Pool Manager or Head Lifeguard may at any time request these be turned down or off.

2:7. The cost of any Club property or recreation room equipment damaged by a member, guest, or child of a member will be charged to the sponsoring member.

2:8. The Club Manager, Assistant Manager, or Head Lifeguard may request any member, guest, or any other person to vacate Club property immediately if they believe it is necessary for the safety or comfort of the membership or in the Club's best interests.

2:9. Overnight parking is not permitted on Club property

2:10-The snack bar is an amenity and is subject to the rules of the Club and may or may not be open at the discretion of the Board of Directors or the Club Managers discretion.

**Section 3: Conduct on Club Property**

**The following are prohibited at all times.**

3:1. Climbing of trees, fences, or buildings or hanging from any basketball nets, hoops, or backboards is prohibited.

3:2. Use and possession of glass containers, alcoholic beverages is prohibited.

3:3. Throwing garbage into the pool or leaving litter on any Club property is prohibited.

3:4. Abusive language, physical violence, dangerous horseplay, screaming, yelling, pretending to be in distress, or inappropriate

sexual behavior is prohibited and you will be asked to leave the grounds.

3:5 No pets or animals of any kind allowed on our grounds. We are a private member club.

3:6 Changing rooms must be used by all members and no changing of clothes in public view will be allowed.

3:7 Operation of bicycles, skateboards, mopeds, or motorized toys. All bicycles, mopeds, and skateboards shall be walked in from the front entrance onto Club property. PLEASE DO NOT RIDE ON THE GRASS!

**The following are permitted only when approved by the Pool Manager or Head Lifeguard and then only in designated areas.**

3:7. Ball playing or other throwing games, including Frisbees.

3:8. Use of rafts or other types of flotation devices, including swim aids.No oversized rafts or boats will be permitted.

**Section 4: Pool Use**

4:1. All members and guests must observe rules and regulations established by the State of NJ, Town of Parsippany, Board of Directors, Pool Manager and Lifeguards

4:2. The Club reserves the right to close sections of the pool for safety or other considerations without prior notice.

4:3. The Manager or Head Lifeguard may evacuate the pool for any health or safety reason at any time.

4:4. In the event of lightning or thunder, all persons must evacuate the pool and pool aprons. New Jersey law dictates that the pool and apron may not be reopened until 30 minutes from the last sign of thunder or lightning.

4:5. Anyone refusing to evacuate the pool when ordered to do so by the lifeguards will be ejected from the club property.

4:6. Patrons must exit the pool by using the ladder or stairs, no one is permitted to climb the gutters to exit.

4:7. No games, running, food, drink, smoking, or personal lawn furniture are allowed on the pool apron.

4:8. Food and Drinks are not allowed in the pool. Smoking is prohibited on pool grounds.

4:9. No free swimming is allowed in or around the diving well.

4:10. All bathers must wear proper bathing attire in the pool. No cut-offs, underwear, or thong-type bathing suits are permitted.

4:11. Diving is prohibited except from the diving boards.

4:12. Pushing into, running into, or cannonballing into the pool from the sides of the pool is not allowed.

**4:13 DIAPERS ARE NOT PERMITTED IN THE MAIN POOL AT ANY TIME, FOR ANY REASON. THIS INCLUDES SWIM TYPE OR DIAPERS SPECIFICALLY DESIGNATED FOR SWIMMING. A \$500 RECLAMATION FEE MAY BE CHARGED TO ANY MEMBER WHO ENTERS THE POOL AND AN ACCIDENT OCCURS.**

**Section 5: Age Restrictions**

5:1. Members must be at least 15 years of age to enter the grounds without a supervising adult.

5:2. Members under the age of 18 may only bring in one guest.

5:3. Members under the age of 15 must remain in the company and under the direct supervision of an adult aged above 18 years old or sponsor member for the entire time of the member's visit.

5:4. Children under the age of 7 must be accompanied by an adult when using the main pool.

5:5. Those 8 years of age or younger may use the kiddie pool.

5:6. No one under the age of 9 may dive from the high board.
